INSTRUMENT OF GOVERNMENT ORDER 2015

1. The name of the school is Brant Broughton Church of England and Methodist Primary School.
2. The school is a voluntary controlled school.
3. The name of the governing body is "The governing body of Brant Broughton Church of England and Methodist Primary School".
4. The governing body shall consist of:
 - (a) 2 parent governors
 - (b) 1 local authority governor
 - (c) 1 staff governor
 - (d) 1 headteacher
 - (e) 2 foundation governors
 - (f) 2 co-opted governors
5. Total number of governors: 9
6.
 - (a) The Lincoln Diocesan Board of Education is entitled to appoint one ex-officio foundation governor.
 - (b) The Lincoln South Methodist Circuit is entitled to appoint one ex-officio foundation governor.
7.
 - (a) The holder of the following office shall be a foundation governor ex-officio:

The Principal Officiating Minister (i.e. the incumbent or priest in charge of the parish in which school is situated or a team vicar with a special cure of souls for the area in which the school is situated)
 - (b) The holder of the following office shall be a foundation governor ex-officio:

Superintendent Minister of the Lincoln South Methodist Circuit.

(c) The Archdeacon of the Archdeaconry in which the school is situated after consultation with the Rural Dean of the Deanery in which the school is situated shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor whose governorship derives from the office named in (a) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21 (1) of the Constitution Regulations.

(d) The Superintendent of the Lincoln South Methodist Circuit shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor whose governorship derives from the office named in (b) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor, or there is a vacancy in the office by virtue of which his governorship exists, or has been removed from office under regulation 21 (1) of the Constitution Regulations.

8. (a) The Archdeacon of the Archdeaconry in which the school is situated, after consultation with the Rural Dean with oversight for the parish in which the school is situated is entitled to request the removal of any ex-officio foundation governor named in 7(a) above and appoint a substitute governor.

(b) The Lincoln South Methodist Circuit may request the removal of the ex-officio foundation governor named in 7(b) above and appoint a substitute governor.

9. Recognising its historic foundation, the school will preserve and develop its religious character in accordance with the principles of the Church of England and the Methodist Church and in partnership with the Churches at parish Diocesan and Circuit level.

The school aims to serve its community by providing an education of the highest quality within the context of Christian belief and practice. It will encourage an understanding of the meaning and significance of faith and promote Christian values through the experience it offers to all its pupils.

10. This instrument of government comes into effect on 1 February 2015.

11. This instrument was made by order of Lincolnshire County Council on the 29th day of January 2015

12. A copy of this Instrument must be supplied to every member of the governing body (and the headteacher if not a governor), any trustees and to the appropriate Diocesan Authority or religious body.
